Introducing POWER Ohio

Now you can get paid for successfully completing higher education courses and degrees and for staying employed with your current early childhood program.

Earn from \$300 to \$12,800

If you're currently enrolled, or plan to start a **Child Development Associate (CDA) Credential** or an **Associate's Degree (AA)** in early childhood education or a related field, you can get paid for classes you pass along the way and for graduating.

Wage Supplement Payments After Graduation

Complete your CDA or AA, stay at your program and you'll qualify for payments at 6 and 12 months.

Benefits

- Get wage supplements without searching for a new employer
- Won't affect other state assistance you receive
- Can be used with your T.E.A.C.H. scholarships
- · Get checks mailed to you

Eligibility

- Assistant teachers earning at or below \$14/hr, lead teachers at or below \$16/hr, administrators at or below \$18/hr
- Work at least 20 hours weekly with children ages birth to 5 years
- Programs already SUTQ rated are eligible for POWER Ohio if at least 50% of the children in the program receive publicly funded child care (PFCC). Licensed programs not yet SUTQ rated are eligible for POWER Ohio if at least one child in the program receives PFCC.
