- 1. Additional 5 required trainings verified in OPR ; see list of trainings on page 3.
- 2. Uploader for updated employment letter added when the application opens.

Supervisor:

- 1. Education -verified in OPR profile
- 2. <u>8 required trainings</u> verified in OPR profile; see list of training on page 3.
- 3. Uploader for employment letter added when the application opens.

Can be renewed one time only:

- 1. Additional 5 required trainings verified in OPR profile; see list of trainings on page 3.
- 2. Uploader for updated employment letter added when the application opens.

EISC 5 year credential

• Coordinator:

- 3. **<u>Reflective Supervision Training</u>** -verified in OPR profile and, when application is open, it can be selected.
- 4. Uploader for employment letter add when the application opens.
