Other combinations to total 12 points



SHARED DELIVERY SYSTEM

Comprehensive




Comprehensive districts are single districts that provide all career-technical opportunities to students either spread across multiple buildings or in concentrated buildings specifically devoted to career-technical programs.



SHARED DELIVERY SYSTEM

Contract/Compact




Compacts are groups of districts that contractually share responsibility without creating a separate joint vocational school district, sharing resources and opportunities across district lines.




SHARED DELIVERY SYSTEM

Joint Vocational School District



Serves adjacent school districts in one or more counties, and each is governed by a joint vocational school board consisting of representatives from the member districts.







PROGRAM DESIGN

COLLEGE CREDIT AND INDUSTRY RECOGNIZED CREDENTIALS



CAREER-TECH ASSURANCE GUIDES (CTAGS), COLLEGE CREDIT PLUS (CCP), AND BILATERAL ARTICULATION AGREEMENTS



Earning College Credits

Every CTE program must be able to provide at least three (3) college credit hours for at least one of their four required course.

College credit opportunities should provide CTE students with direct alignment to a course of study that will lead to employment or certification.

Types of Accelerated Credit

- <u>CTAG</u> College Credit aligned through a CTE Course to a corresponding course at all in-state, public universities. Credit transcripts directly to the student at the university where they have matriculated.
- <u>CCP</u> The student is taking a college course that aligns to a similar course in the CTE pathway. Credit transcripts to the university that the students is enrolled through CCP.
- <u>Bilateral Articulation Agreements</u> The partnering university and the district have entered into an agreement to provide credit for specific courses at their university for any student who completes the aligned course. Credit transcripts directly to the partnering university.
