ECE in Ohio



- Ohio has over 60,000 early childhood workers in all settings
- ECE is "The Workforce behind the workforce"

- T.E.A.C.H. Early Childhood® OHIO Scholarships
 - Early Childhood Associate Apprenticeship
- Career Compass for Health and Human Services- High School Offerings

TEACH Background



- There are 24 states that participate in T.E.A.C.H.
- Acronym that stands for Teacher Education and Compensation Helps
- OCCRRA is licensed to administer TEACH in Ohio
- Began in Ohio in 2003
- Total number of TEACH recipients since inception: 10,729 scholars
- Total number of college degree completed by scholars: 694

TEACH Scholarship Types



- CDA Training College Credit and CCR&R
- CDA Credential Assessment Fee
- Associate of Applied Science in Early Childhood Education or Child Development
 - Apprenticeship is built from this degree Early Childhood Educator
- Bachelor of Arts in Early Childhood Education or Child Development

TEACH Scholarship Recipients



- Professionals who are currently working in the field
- Balancing full-time work with family obligations
- Many may be the first in their family to attend college

College Degree Scholarship Eligibility



- Type A or B Family Child Care Provider, or teacher, assistant teacher, director, or owner employed in a licensed ODJFS early care and learning program.
- Removal of wage cap
- Work at least 30 hours per week with children
- Have worked at your program for 90 days
- Agree to commit to staying at the program for a minimum of one year after completing scholarship.
- Application available through the Ohio Professional Registry.

ECE Associate Apprenticeship



- Technical Assistance Grant from the TEACH National Center started August 2022
- Many of the existing components of TEACH Scholarships align well with apprenticeship structure
- State team was established to serve in an advisory capacity
- In addition to DOL requirements, state registration with ApprenticeOhio is required

Apprenticeship Components



- T.E.A.C.H. Scholar = Apprentice
 - Support role in a center program i.e. Floater or Assistant Teacher
- Mentor = Journey Worker
 - Will be onsite at the employer and likely a Lead Teacher or Administrator
 - Requirements include Bachelor degree and experience; waiver is possible for education
- Apprenticeship
 - Formal Education Associate Degree Coursework 21 credit hours
 - On-the-Job Training 2,000 hours with the journey worker (time-based)
 - Anticipate to last 18-24 months
 - Wage scale increases
 - Layer on top of existing T.E.A.C.H. Benefits and Supports
 - Mentor Training and Supports
 - Employer, Mentor and Apprentice incentives
 - OCCRRA will serve as the sponsoring agency for reporting purposes
