

**Rule 5123-10-05**  
**Early Intervention Program - Developmental Specialist Certification**  
*Effective July 1, 2021*

1-year certification has 2 tracks:

	<b>Obtaining Initial Certification</b> (“Initial” means the <b>first time</b> the certification is applied for under the DS certification rule 5123-10-05)	<b>Maintaining Certification</b> (Renewal after initial certification under 5123-10-05)
<b>1-Year Certification - Track I</b>  <b>For person holding 1-year Developmental Specialist certification issued prior to new rule who is within 1 year of completing 6 college courses/seminars required for 5-year certification</b>	<ul style="list-style-type: none"> <li>• 1-year certification must be in effect</li> <li>• Must be employed as developmental specialist</li> <li>• Must have completed 5 of the 6 required college courses/seminars</li> <li>• Apply for 1-year certification (30-90 days prior to expiration)</li> </ul>	<p><b>During first year</b></p> <ul style="list-style-type: none"> <li>• Complete 6th college course/seminar</li> <li>• Apply for 5-year certification (30-90 days prior to expiration)</li> </ul> <p><b>NOTE: 10 DS orientation modules (see page three) are required prior to application for 5 year certification.</b></p>
<b>1-Year Certification - Track II</b>  <b>For person:</b> <ul style="list-style-type: none"> <li>• Holding 1-year Developmental Specialist certification issued prior to new rule who does not qualify for Track I</li> <li>• With offer of employment or employed as Developmental Specialist who does not qualify for 5-year certification</li> </ul>	<ul style="list-style-type: none"> <li>• Must be employed or receive offer of employment as developmental specialist by employer that arranges for and ensures active participation in evidence-based practice coaching</li> <li>• Must meet one of the following: <ul style="list-style-type: none"> <li>○ Related bachelor's or graduate degree</li> <li>○ Any bachelor's or graduate degree <u>and</u> 2 years paid experience working with children birth through age 5 with disabilities, developmental delays, or diagnosed physical or mental conditions</li> <li>○ Any bachelor's or graduate degree <u>and</u> valid license in related field</li> </ul> </li> <li>• Must have completed 10 Developmental Specialist Orientation modules (listed on page 3 of this document)</li> <li>• Must have completed Department-provided training in Infant and Toddler Development (EI-071)</li> <li>• Apply for 1-year certification (30-90 days prior to expiration if applicable)</li> </ul>	<p><b>During first year</b></p> <ul style="list-style-type: none"> <li>• Start actively participating in evidence-based practice coaching within 6 months</li> <li>• Complete at least 3 college courses or seminars required for 5-year certification including: <ul style="list-style-type: none"> <li>○ Evaluation and Assessment</li> <li>○ Infant/Toddler Growth and Development</li> <li>○ Individualized Family Service Plan Development, Intervention Planning, and Service Delivery</li> </ul> </li> </ul> <p><b>During second year</b></p> <ul style="list-style-type: none"> <li>• Complete 12 months of evidence-based practice coaching</li> <li>• Complete remaining college courses/seminars</li> <li>• Apply for 5-year certification (30-90 days prior to expiration)</li> </ul>

<b>5-Year Certification - Track III</b> <b>For person holding credential issued by another state or U.S. territory</b>	<ul style="list-style-type: none"> <li>Must have met state-approved or recognized certification, licensure, registration, or other comparable requirements to provide special instruction via an early intervention individualized family service plan in a state other than Ohio or a U.S. territory within the past 6 months</li> <li>Must have completed 10 Developmental Specialist Orientation modules (listed below)</li> <li>Apply for 5-year certification</li> </ul>	<p><b>To renew first time:</b></p> <ul style="list-style-type: none"> <li>Complete Principles of Special Instruction</li> <li>Meet one of the following:           <ul style="list-style-type: none"> <li>Complete 50 hours of professional development <u>and</u> work at least 4,000 hours as a developmental specialist</li> <li>Complete 80 hours of professional development</li> </ul> </li> </ul> <p>(Principles of Special Instruction may be counted toward professional development)</p> <ul style="list-style-type: none"> <li>Apply for 5-year certification (30-90 days prior to expiration)</li> </ul> <p><b>To renew thereafter:</b></p> <ul style="list-style-type: none"> <li>Meet one of the following:           <ul style="list-style-type: none"> <li>Complete 50 hours of professional development <u>and</u> work at least 4,000 hours as a developmental specialist</li> <li>Complete 80 hours of professional development</li> </ul> </li> <li>Apply for 5-year certification (30-90 days prior to expiration)</li> </ul>

**Note:** The renewal window opens 90 days from the expiration of certification. Submission of application 30 -90 days before expiration date is advised. Applications received fewer than 10 business days from certification expiration date **may not** be processed prior to expiration. No developmental specialist may provide early intervention services without a valid certification.
